OBAMA CARE SURVIVES

Senator Jeff Merkley of Oregon summed up
the work that is yet to be done in defense
of LGBT people:

- It's still legal in many states to kick someone out of a diner or other public accommodation because of who they love.
- It's still legal in many states to deny important services—like a home loan—to someone because of who they love.
- It's still legal in some states to deny someone housing because of who they love.

Other legal issues will emerge as the nation works through the new direction toward equality for LGB citizens. The most long lasting issues will likely be in found in situations where the country's culture needs to change. As a matter of fact, states that have "enshrined" discrimination against LGBT's into their laws have "just signed a full-employment act for civil liberties lawyers," said the Rev. Barry W, Lynn, executive director of Americans United. "Unfortunately, the state's taxpayers will be stuck with the tab."

new legal changes. Appropriately, many of the human rights groups who have worked so hard on fair treatment of LGB people have indicated that their next big target will be the unfair practices in place against trans-

gender people.

All of the above issues are of deep concern to the United Church of Christ nationally. We at All Peoples UCC share the concern

and will work, both individually and as a congregation to support the work. ▲

UCC NATIONAL NEWS

The 2015 General Synod o the UCC, just finished meeting in Cleveland, OH, this week. If you logged on to the proceedings that were streamed live, you would have seen the full-blown processes of lively discussion, voting and resolution of differences that characterize our denomination.

Important business included resolutions supporting transgender people as they work through the process of transition and an

intensely debated resolution dealing with boycotting corporations that support Israel's suppression of Palestine.

In addition to the resolutions and special events, the various branches of the national UCC presented exhibits. Justice and Witness Ministries brought a full-sized replica of a 6-foot by 9-foot prison "special housing unit," or solitary confinement cell, to the General Synod Exhibit Hall.

The exhibit aimed to raise awareness around practices of mass incarceration and torture, and to mobilize faith communities to advocate for an end to solitary confinements. For many years, these draconian practices were seldom questioned. The time has come to become informed and to ask questions.



€OITOR'S NOTE:

Pope Francis's encyclical titled *Laudato Si* calls out to the entire world a faith-based alarm about global warming. What welcome news to all people of faith who have been stunned by the looming evidence of damage to all of earthly creation.

The Pope's message is hardly news to us but the impact of *Laudato Si*, a skillful integration of theology and science, warms the hearts of those of us who have felt utterly helpless to call attention to the dire messages coming from the scientific community.

Responding to Pope Francis's call to action is still difficult to integrate into our daily lives. Already, we recycle; we try to carpool (whenever possible?); we reduce our consumption of precious resources—water, fossil fuels; and we raise our voices in protest of obvious waste. We call upon our government to implement conservation measures and we boycott corporations who operate outside of earth-friendly bounds.

But impacting global warming requires changes that are much more significant than simply doing the things that we currently do or try to do more efficiently.

Something has to give. That "something" would appear more major than leaders with the power to effect change are acknowledging.

The UK government's "Global Calculator" is a good example. The climate secretary, Ed Davey, claims the calculator shows "everyone in the world can prosper while limiting global temperature rises to two degrees, preventing the most serious impacts of climate change." Recent studies show that that is not a reasonable claim. What can we do, as individuals, to face down this appalling problem?

More vivid awareness is a great place to begin. Our cultural environment sucks

us into an over-consumption spree that becomes invisible if one is not alert. What have we bought lately? More meat than we need? Convenience food? Appliances? How many unnecessary errands have we run? 'Planning a vacation that involves air flight, long road trips, etc.? How much electrical or fossil fuel use is necessary? Are there workarounds?

Changing these behaviors to the extent needed will require ingenuity and will!

The marketplace constantly entices spending on "stuff." One of the most insidious venues for climate-damaging offerings is the internet. Start reading the headlines; notice how tempting they are... currently, ads for travel are everywhere!

Figure out ways to be more self sufficiently "green."...'Got a vegetable garden? Do some sewing. (But beware the enormous prices on fabric and notions.) Eat at home. Patronize the farmer's markets. Shop the periphery of the supermarket, thus avoiding more carbon-intensive prepared foods and beverages in the middle of the store. While at the store, avoid all that fancy

packaging... simpler living is an answer. Study the behavior of corporations and boycott those for whom you have found news of corporate bad conduct. Share your findings!

These suggestions are very humble and not as creative as we need to be.

So, share... share ideas for frugality and simplicity. Especially those of us who are retired have the time that many of the best climate-friendly moves require.

Along with the Pope, we must practice even better stewardship of our world. ▲

UCC RESPONSE TO DECISION ON AFFORDABLE CARE ACT

Barbara Baylor, UCC policy advocate for domestic issues, praised the court for recognizing the intent of the ACA law as extending insurance subsidies in all states. "Thank you, U. S. Supreme Court Justices, for looking beyond the political debates and making the right decision for our country," Baylor said. "Thank you for not putting the health and lives of many at risk. SYNOD APPROVES GREATER UNITY WITH UNITED CHURCH OF CANADA

Two years ago, the General Synod of the United Church of Christ voted to strengthen the denomination's relationship with a neighboring church to the north. Now, the UCC and the United Church of Canada have prepared for full communion between the two North American churches—a partnership in mission intended to enhance the ministry of each denomination—fulfilling the promise the churches made in 2013.

The two denominations look forward to a dynamic and growing relationship. The resolution submitted to the General Synod in Cleveland read in part: "It is a mutual commitment to grow together toward a vision of the church that enriches our theological traditions, enhances service and mission, and deepens worship. The United Church of Canada and the United Church of Christ will find diverse expressions of what it means to live in full communion in Christ as we experience life together." We *are* a uniting denomination and will continue to seek unions with like-minded Christians.

RIGHT WING POLITICS AND RELIGIOUS HARD AT WORK

Americans for Separation of Church and State is joined by progressive organizations in combating legislative and extra-legislative moves that fly in the face of current law and Christian values

Michigan Gov. Rick Snyder(R) recently signed bills that collectively permit publicly funded adoption agencies to discriminate on the basis of religion in placing babies. Most faith-based adoption agencies are sponsored by the Catholic church; they will surely choose not to place adoptive children with same-sex couples.

In another faith-based conflict, ACLU research revealed that Governor Bobby Jindal of Louisiana looks the other way when some public school teachers teach creationism! When Americans United for Separation of Church and State, pointed to the illegality of such instruction, officials hastened to explain that they don't provide the teaching materials. They said that it IS legal to teach from the Bible and to introduce creationism literature (while holding up evolution as just another theory).


